### About Queensland Law Society Incorporated (Parent company)

Queensland Law Society (QLS) is the peak representative body for the solicitor's branch of the Queensland legal profession, providing leadership, guidance and support for more than 13,000 members, across all categories. Incorporated in 1928, QLS holds specific statutory responsibilities under the Legal Profession Act 2007 (LPA). QLS empowers good lawyers, advocates for good law and serves the public good by providing a clear and passionate voice for solicitors and the legal profession in Queensland.

## **About Lexon Insurance Pte Ltd (subsidiary)**

Operating since 2001 as a wholly owned subsidiary of the Queensland Law Society Inc. (**QLS**), Lexon Insurance Pte Ltd (**Lexon**) is a captive insurer providing professional indemnity insurance to QLS members in accordance with the terms of the Queensland Law Society Indemnity Rule 2005 (Qld).

Lexon insures around 2,450 law practices, each of which has at least one office or resident principal in Queensland. These 2,450 practices comprise approximately 7,500 Queensland PC holders and over 1,100 interstate practitioners.

In addition to its primary role of providing the compulsory (\$2M each and every claim) professional indemnity cover required by each practice, Lexon also offers optional top up cover (to a maximum of \$8M) for those seeking greater insurance protection based on their individual needs.

Lexon is incorporated in Singapore and has local managers for Singapore regulatory compliance matters. Lexon's board has nonetheless elected to measure its solvency against key Australian Prudential Regulatory Authority (**APRA**) standards – some of the most robust in the world - with all related actuarial work being undertaken by leading Australian firm Finity Consulting Pty Ltd (**Finity**).

The Lexon Memorandum and Articles of Association sets out the composition of the Lexon Board, which includes two QLS Council representatives (QLS Nominee Director), appointed by the QLS Council.






# **Organisational Structure**

#### **Genevieve Dee**

Genevieve is an accredited specialist in Family Law, partner at Lander & Rogers and the QLS President for 2025. Genevieve has practiced exclusively in family and relationship law for over 15 years. She has served two terms as councillor of the Queensland Law Society and has previously been a member of the Committee of Management and the Specialist Accreditation Board, including a term as Chair. Genevieve is one of the two QLS Nominee Directors of Lexon and will be retiring from that role on 30 June 2025.

#### **Elizabeth Shearer**

Elizabeth Shearer is a general practice solicitor who specialises in the legal problems of everyday life. She sees her role as general counsel for individuals and small businesses, and her practice encompasses family law, consumer law, estate law, property law and the various types of law dealt with in civil and administrative tribunals. She has been a solicitor for almost 40 years, with a significant part of her career in the legal assistance sector, including as Director of Civil Justice and Information and Advice Services at Legal Aid Queensland. She has also worked in policy and executive management in the public sector, and as a consultant to government and peak bodies on design and evaluation of legal assistance services.

Elizabeth is also the founder of Affording Justice. This is a model of practice, pioneered by Elizabeth, offering discrete task services to meet the needs of "the missing middle" – that is people who are not eligible for legal aid, and who might not otherwise engage legal help when they need it. Elizabeth was the President of the Queensland Law Society in 2021 and is currently a QLS Nominee Director of Lexon, QLS Senior Counsellor, member of the Ethics Advisory Committee, and chair of the QLS Access to Justice Pro Bono Law Committee. The Queensland Law Society awarded Elizabeth the Agnes McWhinney award in 2024. This award recognises a female lawyer who has forged new pathways through a commitment to excellence, equity, professionalism and service to the community.

Elizabeth is Law Council of Australia Treasurer and is a longstanding member of the Law Council of Australia's Access to Justice Committee and the LCA's nominee on the Australian Pro Bono Centre Board. She is also a member of the University of Queensland Pro Bono Centre Advisory Board, and a member of the Professional Standards Councils of all States and Territories. She holds a Bachelor of Arts and Bachelor of Laws (Hons) from the University of Queensland and a Masters Degree in Law and Management from the University of New South Wales. Elizabeth is also a Churchill Fellow.
